The envelope superscribing 'Technical Bid' should contain the quality / brand along with authorization, registration certificate and Demand Draft of Rs.50,000/- (Rupees Fifty Thousand Only) towards security deposit and the other envelope superscribing 'Price Bid' should be quoted against each individual items separately on door delivery basis. The quotations shall be opened on a date to be separately intimated later in presence of representatives of suppliers. Once the Purchase Order is placed against the enlisted supplier / vendor, he shall be bound to supply the 'ordered quantity' for the abovementioned period from the date of award with the ordered price failing which the security money stand forfeited.
