- **6. <u>DESTINATION FOR SUPPLY OF NEWSPRINT:</u>** Any destination within Odisha (Cuttack, Sambalpur & Balasore). Destination will be specified in each month's supply order.
- 7. DELIVERY SCHEDULE: Within 7 to 10 working days of date of receipt of supply order.
- **8.** Tenders must be submitted <u>on the prescribed form for the information asked only</u> for the 'Technical' and 'Financial' Bids. Tenders on letter-head / any other paper will be summarily rejected.
- QUOTED RATES: Rates should be "All Inclusive" on FOR destination on firm and fixed basis for entire rate-contract period.
- **10.** Tenderers are required to fill-up and submit the **'Technical' and 'Financial'** bids in 2 separate sealed envelopes. **'Financial bid'** envelope should contain only the quoted rates.

The `Technical bid' envelope should contain all the other required / essential documents mentioned in this tender. Both these envelopes must be sealed separately and should be super-scribed by words 'Technical Bid' / 'Financial Bid', as the case may be. These two sealed envelopes should then be placed inside a third big envelope, which should also be sealed properly and super-scribed with words 'Tender for SUPPLY OF NEWSPRINT PAPER. The Financial Bids shall be opened at a later date after evaluation. Tenderers, whose documents are found to be complete in all respects, will be notified of the 'opening date' of the 'Financial Bids' in advance. - <u>EARNEST MONEY DEPOSIT</u>: Tenderers will have to submit an <u>Earnest Money Deposit (EMD) of Rs. 1 Lakh Rupees One lakh only</u> in the form of Demand Draft/ Banker's Cheque from Scheduled / Nationalized Bank favoring THE SAMAJA payable Cuttack. <u>Please note separate technical bid to be filed for front and inner page and preference will be given to bidder who can supply at all location (Cuttack, Balasore and Sambhalpur).

- 2. The Samaja reserves the right to accept or reject any / all the tenders withoutassigning any reason thereof at any stage.
- 3. Office of The Samaja reserves the right to terminate the rate-contract with onemonth's notice.
- 4. The successful tenderer will have to sign an 'Agreement' for rate-contract within 7days of issue of the rate acceptance letter by this office.

General Terms & Conditions-

The Suppliers should clearly mention the standard parameters of specifications of their Newsprint as per the International/National parameter. The rate should be quoted on 'Door Delivery' basis at our Edition Centers le. Cuttack, Sambalpur & Balasore which includes transport worthy packing, loading, transportation, Insurance, GST and all other taxes as applicable. Interested parties should send their quotations by Registered Post/Speed Post/Courier Service in a sealed cover for Technical Bid along with samples in rolled form [size:) and Price Bid separately. The envelope superscribing 'Technical Bid' should contain sample(with seal and signature of the authorized signatory thereon), Technical Specifications, especially basic properties such as physical, optical, chemical etc. of Newsprint and Demand Draft of Rs.1,00,000/- (Rupees One Lakh Only) towards Security Deposit and the second envelope superscribing 'Price Bid' should contain rate of the different Newsprints. The main envelope containing both the bids should be superscribed "Quotations for supply of Newsprint" with contact details (Telephone / E-mail ID) so as to reach the undersigned on or before 31.03.2025 and the date of opening of Tenders will be intimated to Tenderers by E-Mail / Telephone well in advance. Tenders received after the stipulated date shall not be considered. The quotations must accompany the letter of authorization from the Newsprint manufacturer in case of Dealers/Distributors at the time of agreement. Purchase Order shall only be issued to such successful bidders and they shall be required to sign necessary Agreement with 'The Samaja'. Once the Purchase Order is placed, the Supplier shall be under obligation to supply the ordered quantity on weekly/fortnightly basis as per the terms and conditions agreed to, failing which their securitymoney shall stand forfeited . The Security Deposit shall be refunded to unsuccessful bidders after finalization of the Tender without interest within 30 days. Canvassing in any form in this regard shall be treated as a disqualification. Any Dispute Pertaining To The Matter Is Subject To The Jurisdiction Of CourtsIn Cuttack Only and as per the ARBITRATION AND CONCILIATION (AMENDMENT) ACT, 2019. The Management reserves the right to select/reject any quotation/quotations for supply of Newsprint as mentioned above without assigning any reason thereof. Damaged reels shall not be accepted and willbe notified to the supplier as soon as the same is noticed. The supplier will have to lift back the said damaged reels from storage godown at their own cost. Full cost of such returnable reels will be deducted from the supplier bill/security. In case successful bidder is not in a position to supply newsprint against a particular supply order due to reasons beyond control, supplier will have to inform this office **URGENTLY** in time. In case of such default the supplier will have to bear the risk and cost of the purchase from the open market. The Samaja will have a right to purchase required Newsprint from open market and the difference in price, if any, will be recovered from the supplier.
